August 26 is Women's Equality Day

Women's Equality Day celebrates the anniversary of the ratification of the 19th Amendment on August 26, 1920, which finally gave American women the constitutional right to vote. It also celebrates the founding that same year of the League of Women Voters in the United States.

The exhibit tells the stories of four members of the Stanton family as they relate to Oxford and Miami University in the 19th Century and to struggles for freedom and equality. All four Stantons were remarkable, but the most important was Elizabeth Cady Stanton, who in 1848 in Seneca Falls, New York, launched the campaign for women's suffrage.

The Stanton exhibit is co-sponsored by the McGuffey Museum and the League of Women Voters of Oxford and is the result of a collaboration of four League members: Sallie Killian, Steve Gordon, Jo McQueen and Toni Saldivar.

Elizabeth Cady Stanton's Descendant Visits Oxford Landmark House and the LWVox McGuffey Museum Exhibit.

Elizabeth Cady Stanton's great great granddaughter, Coline Jenkins, a LWV member from Greenwich, CT, recently visited the historic Oxford, Ohio, house where her famous foremother stayed when lecturing at Miami University in 1870. Built in 1868, and known today as the Stanton-Bonham House, it was the home that Jenkins' great great great uncle, Robert L. Stanton, D.D., constructed while he was president of Miami University. His sister-in-law, Elizabeth Cady Stanton, brought to the all-male university her message of equal rights for women, which included the Constitutional right to vote. The student newspaper gave her a favorable review.

That 1870 article from *The Miami Student* was one of the items Ms. Jenkins saw in the exhibit about her family currently up in the McGuffey Museum at Miami University. The exhibit, titled "The Remarkable Stantons and the 'Magnificent Dwelling,' " highlights the courage of members of the Stanton family who led efforts to end slavery and, in the case of Elizabeth Cady Stanton, who promoted women's equality. This exhibit was created by four members of the League of Women Voters of Oxford: Steve Gordon, Sallie Killian, Jo McQueen, and Toni Saldivar. Gordon is the Administrator of the McGuffey Museum of Miami University.

Following the August 4 exhibit tour and a visit to the Freedom Summer Memorial on MU's Western Campus, Ms. Jenkins and her colleague Marsha Weinstein, past president of the LWV of Louisville, KY, were guests at a private luncheon in the Marcum Center. Jenkins and Weinstein, co-founders of the Elizabeth Cady Stanton Trust, addressed invited guests from both Oxford and Miami University. They discussed their work promoting equality for women and linking the struggle for women's rights to the struggle for human rights, local and global.

Update on Recent Court Cases

There have been several recent court cases that state Leagues have been involved in that I think might be of interest to you. First you may have heard that the League of Women Voters of Ohio is presenting a case, along with the ACLU, the NAACP, and several African-American churches, to try to restore early voting opportunities for Ohioans in time for the November midterm election. They were in federal court on August 11th to ask for three things: restore Golden Week, restore multiple Sundays during the early voting period, and restore voting on multiple weekday evenings during the early voting period. Other state Leagues are also working hard to restore voter rights and to push back on gerrymandering efforts across the country. One case that is especially interesting in light of Ohio's redistricting issues is a ruling made at the beginning of August by a circuit court judge in Florida. This judge ruled that the Florida Legislature must immediately revise its flawed congressional map. This case was brought by the League of Women Voters of Florida and is being hailed by the national League of Women Voters for setting an important precedent against political gerrymandering.
